Message From the Chief

2013 was an eventful year for the Monroeville Police Department. It saw the resignation of Officer Bush as part time police officer and the hiring of Officers Thane Telquist and Jacob Spettle.

We also grieved at the unexpected passing of Brian M. Biecheler. Officer Biecheler worked part time at the Monroeville Police Department for a number of years. He will be remembered as someone who always had a smile and was an exemplary employee and professional. He will be missed.

Drug Task Force

Officer Troy Kimball continues to work in his capacity as a Special Deputy for the Huron County Sheriff's office and has participated in numerous cases with county-wide Drug Task Force. A number of notable arrests have occurred so far this year that include from Heroin and Meth-Amphetamine trafficking as well as Magic Mushrooms. The hours spent helping in the investigations are being funded by money in the police department's drug fine money and has not had an impact on the day to day budget.

Community Outreach Programs

Hooked on Fishing.



On Saturday May 11th the Monroeville Police Department held its annual Hooked On Fishing event at Marsh Park. Hooked On Fishing is designed to provide alternatives to youth and promote the joys of fishing. Funds to sponsor the event were provided for in part by a grant from the Ohio Department of Natural Resources and private donations from businesses and individuals in and around the Monroeville area.

Approximately 40 people participated in the event. Food and beverages were provided and prizes were awarded to the youth angler who caught the largest fish, the smallest fish, and the most fish.

Safety Town

During the week of July 7th, the Monroeville Police Department along with the Huron River Joint Fire District Fire Department conducted its annual Safety Town. Safety Town focused on many safety issues such as bicycle and pedestrian safety, fire safety, use of 911 system, and stranger danger awareness Sgt. Frank Gleason and Mr. Phil Charville represented the police department. We would also like to thank the many volunteers of the Fire Department who donated their time for this event. Approximately 35 children graduated from Safety Town this year.

New Records System

The Monroeville Police Department joined other public safety agencies in coming to an agreement with Alert Tracking Systems Inc. in the implementation of a new multi-jurisdictional records system. The product was purchased with grant money through the Huron County Emergency Management agency. This system will replace the Law Enforcement Officer's Tool Kit currently provided by the State of Ohio. This product is due to be discontinued in June 2014. The new records system will provide all public agencies a superior records package and allow agencies to share common data.

The fleet currently consists of the new 2013 Ford Interceptor and one 2010 Ford Crown Vic Police Interceptors.


Cost Recovery

In 2013 there was a significant reduction in the number of reported accidents to the Monroeville Police Department. Nine accidents were reported to Cost Recovery and they billed those individuals \$2,402.40 for services provided by the police department. \$418.20 has been collected as of December 31, 2013.
